- Unexpected Difficulties:** Brad Olesiak, 218-428-6326 - Brian Karich, 218-969-3716
- Divisions of Play:** Higher Skilled 12's are placed in the Queens Division.
Lower Skilled 12's are placed in the Princess Division.
- Playoff Brackets:** All teams will advance to championship bracket play.
- Tournament Information:** Team reps and coaches are responsible for all tournament information and procedures.
- Match time is forfeit time. If teams are not ready to play set one a forfeit will be declared. After 15 minutes, if still not ready, the second set / match will be forfeited.
 - The tournament manager / pool statistician will post results.
- Playing Modifications:**
1. Teams shall provide a volleyball-lite for play.
 2. Each player is allowed three consecutive serving points during a term of service. After the third consecutive serve (point) the opponent will be awarded the ball to serve, but no point will be awarded.
 3. The serving end line will be measured 24 feet from mid-court.
 4. Net Height – 7'.
 5. Substitution Procedure – Coaches must administer the substitution by entering the substitution zone with the substituting player / players.
- Officiating:**
- Requirements**
- Teams must supply a scoresheet ticker, a score board flipper and line judges.
 - A coach must be the R1.
 - Adult supervision at the scorer's table is recommended.
 - No Electronic Devices or food will be allowed at the scorekeeper's table.

Food Policy: **ABSOLUTELY NO FOOD OR BEVARAGE IS ALLOWED IN THE PLAYING FACILITY. ONLY WATER MAY BE AT COURT SIDE ON ANY PLAYING COURT. Coolers or picnic baskets may not be brought into the tournament venues. Teams and spectators will be checked at the door.** Concessions will be available. This policy includes scoring tables.

Team Areas: Teams will be allowed to camp in open / common areas. Teams may not camp on gym floor areas. Teams **must keep their camp** clean during the event and before they leaving.

Spectator Viewing: All venues will have spectator seating. Please keep seating areas and bleachers clean.

Pool Play Match: All teams will advance to championship bracket play.
A four-team pool match play will be 2 sets to 25 points, no cap.

Teams will be seeded into playoffs based on sets won /sets lost.

- **Two Way Tie Breaking Procedure**
 1. Head to head competition – plus / minus factor.
 2. If still tied - total plus / minus factor of all sets played.
 3. If still tied – a one set playoff to 9.
- **Three Tie Breaking Procedure**
 1. Plus / minus factor of all sets played.
 2. If a tie, Head to head competition - plus / minus factor.
 3. If still tied, a one set playoff to 9.

Playoffs Matches:

1. Playoffs start immediately following pool play.
2. Tournament managers will announce pool results and bracket matches.
3. Playoff matches will be the best 2 out of 3 sets. Set 1 & 2 to 25 points, set 3 to 15 points, team exchange sides of court at 8 points in the third set.

POOL PLAY SCHEDULE

Note #1 Warm-up periods are 10 minutes (2-4-4) or 5 minutes (1-2-2). Shared Court, followed by serving team's court, then follow by the receiving team's court. All playoff matches will have a five-minute warm-up period.

Note#2 Teams that play a succeeding match should be **ON DECK** when 10 points remain in the second set of current match being played. **The on-deck procedure will prevent a set / match forfeit.**
