Tournament Information: Team reps and coaches are responsible for all tournament information and procedures.

Match Time: Match time is forfeit time. If teams are not ready to play set one a forfeit will be declared. After 15 minutes, if still not ready, the second set / match will be forfeited.

Facility Policies:

1. Team Camp Area

- **Common areas only. Teams may not camp on any part of a gymnasium floor / playing court.**

2. Playing Courts

- **Only Active players and coaches may be on the court.**
- **No food is allowed on the playing court or at the scorer's table.**

3. Spectator Viewing

- **High School Auxiliary Gym – Court One, bleacher Seating.**
- **High School Main Gym – Court Two, Three and Four.**
 - **No Bleacher Seating - Standing room balcony track.**
- **Middle School Gym, Court Five and Six, bleacher seating.**

Officiating:

North Country Region officiating requirements will apply.

- **Seven person officiating team. R1, R2, L1, L2, Scorekeeper, Timekeeper and Libero Tracker.**
- **Only assigned officials are allowed at the scorekeeper's table.**
- **No Electronic Devices or **food** will be allowed at the scorekeeper's table.**
- **Adult supervision at the scorer's table is recommended.**

Playing Rules: All play will be governed by USA volleyball rules.

Equipment: **Balls** Teams are responsible to provide balls for warm-ups and matches.
Whistles Do not forget.

Pool Play Match: **The first and second place team in each pool qualify for Championship Bracket Play and the third and fourth team in each pool qualify for the Consolation Bracket Play.** Match play will be two sets to 21 points, no cap. Teams will be seeded into bracket play playoffs based on sets won /sets lost.

- **Two Way Tie Breaking Procedure**
 1. Head to head competition – plus / minus factor.
 2. If still tied - total plus / minus factor of all sets played.
 3. If still tied – a one set playoff to 9.
- **Three Tie Breaking Procedure**
 1. Plus / minus factor of all sets played.
 2. If a tie, Head to head competition - plus / minus factor.
 3. If still tied, a one set playoff to 9.

Playoffs Matches:

1. Playoffs start immediately following pool play.
2. Tournament managers will announce pool results and bracket matches.
3. Playoff matches will be the best 2 out of 3 sets. Set 1 & 2 to 25 points, set 3 to 15 points, team exchange sides of court at 8 points in the third set.

Awards: **CHAMPIONSHIP BRACKET: First Place – Medals, Second Place – Medals**
CONSOLATION BRACKET: First Place – Medals

POOL PLAY SCHEDULE

Note #1

Warm-up periods are 10 minutes (2-4-4) or 5 minutes (1-2-2). Shared Court, followed by serving team's court, then follow by the receiving team's court. **All playoff matches will have a five-minute administered warm-up period.**

Note#2 Teams that play a succeeding match should be **ON DECK** when 10 points remain in the second set of current match being played. **The On Deck procedure will prevent a set / match forfeit.**
