- Unexpected Difficulties:** Wayne Kangas, 218-290-7273 - Brian Karich, 218-969-3716
- Divisions of Play:** More experienced 12's / 10's are placed in the HUMMA Division.
The less experienced 12's / 10's are placed in the HYAH Division.
- Playoff Brackets:** All teams will advance to the playoffs.
Playoff announcements will be made on court number one following completion of all pool play. HUMMAH HYAH CHANT TIME!!!!
- Tournament Information:** Team reps / coaches are responsible for all tournament information and procedures.
- Match time is forfeit time. If a team is not ready to play at the scheduled time, a set forfeit will be declared. After 15 minutes, if still not ready, the match will be forfeited.
 - The tournament manager / pool statistician keeps results at a designated tournament management area.
 - Only team coaches / club directors are allowed in the tournament management areas.
 - All players must have signed a liability of release form. Coaches are to keep forms in their possession for all matches.
- Playing Modifications:** See play modifications & rules on the website at www.divesportspluswear.com.
- Food Policy:** **ABSOLUTELY NO FOOD OR BEVARAGE** is allowed in the playing facility. Only water / fluid replacements may be at court side / team bench area. This policy includes scoring tables.
- Coolers or picnic baskets may not be brought into the tournament venues. Teams and spectators will be checked at the door. Concessions will be available.

Team Areas:

Teams will be allowed to camp in open / common areas. Teams may not camp on gym floor areas. Please keep the team camp clean during the event and before they leave.

Spectator Viewing:

All venues will have spectator viewing areas.

Playoff Brackets:

All teams advance to championship bracket play.

Teams will be seeded into playoffs based on sets won /sets lost in pool play.

- **Two Way Tie Breaking Procedure**
 1. Head-to-head competition – plus / minus factor.
 2. If still tied - total plus / minus factor of all sets played.
 3. If still tied – a one set playoff to 9.
- **Three Way Tie Breaking Procedure**
 1. Plus / minus factor of all sets played.
 2. If a tie, Head-to-head competition - plus / minus factor.
 3. If still tied, a one set playoff to 9.

Playoffs Matches:

1. Playoffs start immediately following pool play.
2. Tournament managers will announce pool results and bracket matches at court number one. All teams and player should be present.
3. A playoff match is the best 2 out of 3 sets. Set 1 & 2 to 25 points, set 3 to 15 points.
4. Exiting teams are to check in with the EM before they leave. This procedure is a double check to make sure that you do not have officiating responsibilities.

POOL PLAY SCHEDULE

Note #1 Warm-up periods are 10 minutes (2-4-4) or 5 minutes (1-2-2). Shared Court, followed by serving team's court, then follow by the receiving team's court. All playoff matches will have a five-minute warm-up period.

Note#2 Teams that play a succeeding match should be **ON DECK** when 10 points remain in the second set of the current match being played. **The on-deck procedure will prevent a team set / match forfeit.**
