**Divisions of Play:** More experienced **13/14 teams** are placed in the Queens Division and will play at Mesabi East.  
Less experienced 13/14 teams are placed in the Princess Division and will play at Hermantown.

**Tournament Information:** Team reps and coaches are responsible for all tournament information.

- Match time is forfeit time. If teams are not ready to play set one a forfeit will be declared. After 15 minutes, if still not ready, the second set / match will be forfeited.
- The tournament manager / pool statistician will post results.
- **Only team coaches / club directors are allowed in / near tournament management areas.**
- All players must have a signed a liability of release form. Coaches are to keep forms in their possession for all matches.

**Food Policy:** **ABSOLUTELY NO FOOD OR BEVARAGE** is allowed in the playing facility. Only water / fluid replacements me be at court side / team bench area. This policy includes scoring tables. Concessions will be available.

**Team Areas:** Teams will be allowed to camp in open / common areas. Teams may not camp on gym floor areas. Please keep the team camp clean during the event and before your team leaves for the day.

- Facility Policies:** Playing Courts - Only Active players and coaches may be on the court.
- Officiating:** **See Tournament Playing Rules and Procedures.**  
 Note: Teams that appear in parenthesis on the pool schedule will be the officiating team.
- Playing Rules:** All play will be governed by the National Federation of High School volleyball rules. **See Tournament Playing Rules and Procedures at [www.divesportspluswear.com](http://www.divesportspluswear.com).**
- Equipment:**
- Balls** Teams are responsible for providing balls for warm-ups / matches.
- Whistles** Do not forget.
- Pool Play Match:** Match play with four team pools will be two sets to 25 points, no cap. Match play with three team pools will be three sets to 25 points, no cap. Teams will be seeded into playoffs based on sets won / sets lost.
- Two Way Tie Breaking Procedure**
1. Head-to-head competition – plus / minus factor.
  2. If still tied - total plus / minus factor of all sets played.
  3. If still tied – a one set playoff to 9.
- **Three Tie Breaking Procedure**
    1. Plus / minus factor of all sets played.
    2. If a tie, Head-to-head competition - plus / minus factor.
    3. If still tied, a one set playoff to 9.
- Playoffs Matches:**
1. Queens Division: 1<sup>ST</sup> & 2<sup>nd</sup> Place teams in each pool will qualify for the Gold Playoffs and 3<sup>rd</sup> and 4<sup>th</sup> place teams in each pool will qualify for the Silver Division.
  2. Princess Division: All teams qualify for the Gold Playoffs.
  3. Playoffs start immediately following all pool play.
  4. Tournament managers will announce playoffs at courtside of main gym.
  5. Playoff matches will be the best 2 out of 3 sets. Set 1 & 2 to 25 points, set 3 to 15 points.
